

**Order Levying Taxes 2023**  
**Williamson County Emergency Services District #7**

**THE STATE OF TEXAS §**

**COUNTY OF WILLIAMSON §**

**WHEREAS**, the appraisal roll of Williamson County Emergency Services District #7 (the "District") for 2023 has been prepared and certified by the appraiser for the District and submitted to the District's tax assessor/collector, and

**WHEREAS**, the Chief Appraiser has submitted the certified appraisal roll for the district, dated July 20, 2023, showing \$1,100,422,053 to be the total appraised, assessed and taxable value of all property and the total taxable value of new property, to the Board of Emergency Services Commissioners of the District; and

**WHEREAS**, based upon the certified appraisal roll, the employee or officer designated by the Board of Emergency Services Commissioners of the District has calculated a tax rate to be levied for 2023 sufficient to provide tax revenue to meet the District's obligations;

**NOW, THEREFORE, BE IT ORDERED BY THE BOARD OF EMERGENCY SERVICE COMMISSIONERS OF WILLIAMSON COUNTY EMERGENCY SERVICES DISTRICT #7 THAT:**

**"THIS TAX RATE WILL RAISE MORE TAXES FOR MAINTENANCE AND OPERATIONS THAN LAST'S YEAR TAX RATE" AND "THE TAX RATE WILL EFFECTIVELY BE RAISED BY 3.499% PERCENT AND WILL RAISE TAXES FOR MAINTENANCE AND OPERATIONS ON A \$100,000 HOME BY APPROXIMATELY \$2.15."**

**Section 1.** There is levied an ad valorem tax of \$0.063599 for each \$100.00 of taxable property within the district in order to provide funds for maintenance and operating purposes.

**Section 2.** There is levied an ad valorem tax of \$0.016567 on each \$100.00 of taxable property within the District in order to provide funds for the purpose of debt service.


**Section 3.** All taxes collected pursuant to this levy, after paying costs of levying, assessing and collecting the taxes, will be used for paying costs of providing emergency services and organization and administrative expenses, including legal fees, and for paying principal of and interest on bonds, warrants, certificates of obligation or other lawfully authorized evidence of indebtedness issued or assumed by the unit.

**Section 4.** The Williamson County Tax Assessor/Collector is authorized to assess and collect the taxes of the District employing the above tax rate.

**Section 5.** The taxes levied by this Order are due presently and will be delinquent if not paid by January 31, 2024.

**Section 6.** This Order Levying Taxes is effective from and after its adoption.
